

PERMISSION FOR THE PROCESSING OF PERSONAL INFORMATION

As you have certainly learned in the media, the new Personal Information Protection **Act (POPI Act 4 of 2013)** came into effect 1 July 2021. This also means that we must comply with the necessary requirements by obtaining permission from you as our client that we may indeed collect and store your personal information for which we may use it. (Here is also the link to the website of the legislation should you require more information. www.popia.co.za)

For purposes of this consent, the words *Personal Information (personal information)*, *Data Owner (data subject)*, *Handling (processing)*, *Responsible Party (responsible party)* and *Service Provider (operator)*, will have the same meaning as defined in the Protection of Personal Information Act, 4 of 2013 (**POPIA**).

representative of _____ (the COMPANY/CC/INDIVIDUAL) hereby voluntarily grant permission that P S P Timber Industries (Pty) Ltd may handle personal information of the company/CC/Individual for the lawful business purposes, functions or activities of P S P Timber Industries (Pty) Ltd. The type of information will depend on the purpose for which it is collected and will also only be handled for that purpose.

All Personal Information will, as far as possible, be processed by P S P Timber Industries (Pty) Ltd (as the Responsible Party), but the Company/CC/Individual gives permission that P S P Timber Industries (Pty) Ltd may instruct other organizations to provide support services as Service Providers or Operators to P S P Timber Industries (Pty) Ltd and P S P Timber Industries (Pty) Ltd are hereby authorized by the Company/CC/Individual to allow such Service Providers and Operators access to the Companies/CC/Individuals Personal Information to process the Personal Information for the purposes of such support services. P S P Timber Industries (Pty) Ltd will bind Service Providers to its privacy policy insofar as it accesses the Companies/CC/Individuals Personal Information.

Purpose for which Personal Information is processed:

We also want to make sure that you understand how and for what purpose we handle your personal information. We collect, like, use and disclose your personal information primarily to give you access to

P S P Timber Industries (Pty) Ltd's range of services and products available to you. We will process your information only for a purpose that you would reasonably expect, including:

1. Provide you with advice, products and services that meet your request;
2. To confirm your identity and to check credit references;
3. To arrange, administer, and manage logistics functions;
4. To process documentation required for the import/export process;
5. To notify you of new products or developments that may be of interest to you;
6. To confirm or update your details;
7. To make payments or receive from you for services or goods delivered;
8. To act in P S P Timber Industries (Pty) Ltd or the company's legitimate interest;
9. To give effect to any legal or legislative obligations on P S P Timber Industries (Pty) Ltd.

You have the following rights:

1. The right to know what personal information is kept, how it is handled, and when P S P Timber Industries (Pty) Ltd discloses it.
2. The right to correct your personal information.
3. The right to withdraw this permission.
